The magnetic heads in a disk drive are of a gimbal type in which a head slider is fixed on a tongue of a load beam made of a stainless steel plate. The magnetic head is bonded to the slider. The slider is in contact with a disk as the slider flies on the disk due to an air flow generated by the rotation of the disk. The slider is elastically deformed during flying on the disk. In this manner, a tilt angle of the slider with respect to the disk can be kept in a constant range, so that a magnetic field can be applied to a desired track on the disk and the magnetic information can be accurately reproduced.
